Minutes of a meeting of Luppitt Parish Council held in the Village Hall on Tuesday, 5 March 2024 at 8 pm

1.1 Receive apologies for absence

Apologies were received as above.

1.2 Minutes of previous meeting

The Minutes of the meeting held on Tuesday, 6 February 2024, were unanimously agreed and signed as a correct record of that meeting (proposed by Cllr Thorne and seconded by Cllr Summers).

1.3 Declaration of Interest

Cllr Tucker declared an interest in item 2.1.1, the planning application at Blackenfields Farm, as he carries out work at that location.

2.0 PLANNING

2.1 Applications (for comment, support or objection)

2.1.1 23/1770/AGR – Blackenfields Farm, Luppitt, EX14 4UB – erection of general purpose agricultural building

The clerk will ask Planning if there is any further correspondence that has not been uploaded to the website as some of the points raised in the Planning Officer's letter dated 7 September to the agent have not been addressed to the satisfaction of the Parish Council. There is no justification for the location or the need for such a large building on a non-functional farm.

2.1.2 24/0218/VAR – Spurtham Farm, New Road, Upottery, EX14 9QD – variation of condition 2 (approved plans), and removal of condition 3 (external materials) on application 23/1376/FUL – erection of rural worker's dwelling

The Parish Council does not support the variation of Condition 2 and removal of Condition 3. The Parish Council believes that the original materials listed in the planning application 23/1376/FUL should be retained in keeping with other properties in the area and policy ND2 of the Neighbourhood Plan.

2.1.3 24/0283/AGR - Stockers Farm, Wick, EX14 4TY - polytunnel

The Parish Council would like confirmation that the polytunnel is for domestic use only. Clause 5.4 of the Luppitt Neighbourhood Plan (page 32), paragraph 10 of section 7.5 (pages 57 and 58) and Policy ND6 should be referenced when reaching a decision on this application. These items deal with discouraging both urban creep and introducing larger and more intensive agricultural buildings into the landscape.

2.2 Decisions

23/2414FUL - The Robins, Luppitt, EX14 4TR - approved.

2.3 REPORTS

2.3.1 Ward Councillor

Cllr Levine reported that EDDC only needs to have a 4-year land supply instead of a 5-year land supply previously.

2.3.2 County Councillor

Cllr Chubb reported that Devon County Council has reached a balanced budget. Money is being allocated from the HS2 project which will be used for repair of highways. A consultation is being held on the proposed devolution deal with Torbay.

5.1 Community Actions

Cllr Turner reported that parishioners Roger Hicks and Christine Ryder have agreed to remain members of the Community Management Action Group for the time being. Roger Hicks has also agreed to investigate the feasibility of arranging a litter pick around the parish.

5.2 Housing Needs Survey

Angela King at EDDC is arranging for the Housing Enabling Officer to contact the clerk to discuss a Housing Needs Survey for Luppitt.

5.3 Arrangements for 80th Anniversary of D-Day

The clerk has received confirmation of agreement from the directors of Luppitt Commons Ltd to use the field at Hartridge for the commemoration event. Cllr Thorne confirmed that he has ordered the fireworks.

5.4 Play Area Inspection

RoSPA has confirmed that both play areas will be inspected shortly and the clerk has forwarded details to Cllrs Pulman and Summers. The clerk was asked to establish who owns the hedges at the play area field at Mill Rise.
